






HIGH LEVEL RESULTS

- 30,834 OIA requests were completed in the six months to December 2023.
- 30,256 (98.1%) OIA requests were completed within legislated timeframes.
- 2,533 OIA responses were published during the six months to December 2023.
- New Zealand Police and New Zealand Defence Force are reported separately.
